ARTICLES OF AMENDMENT ARTICLES OF INCORPORATION

Pursuant to Section 617.1006, Florida Statutes, the undersigned corporation adopts the following articles of amendment to its articles of incorporation.

FIRST

The name of the corporation is: William F. and Elizabeth R. Leonard Private Foundation Inc.

SECOND

The following amendment to the articles of incorporation was adopted by the corporation:

ARTICLE XVI – INTERNAL REVENUE CODE PROVISIONS

- (a) The Corporation shall distribute its income for each tax year at such time and in such manner as not to become subject to the tax on undistributed income imposed by section 4942 of the Internal Revenue Code of 1986, as amended.

- (c) The Corporation will not retain any excess business holdings as defined in Section 4943 (c) of the Internal Revenue Code of 1986, as amended.
- (d) The Corporation will not make any investments in such manner as to subject it to tax under Section 4944 of the Internal Revenue Code of 1986, as amended.
- The Corporation will not make any taxable expenditures as defined in Section (e) 4945 (d) of the Internal Revenue code of 1986, as amended.

THIRD

The amendment was adopted by the unanimous vote of the members of the corporation on the 29 th day of March, 2001.
