ARTICLES OF INCORPORATION  
OF

A CORPORATION NOT-FOR-PROFIT

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of the corporation shall be : **SHABROWN COMMUNITY DEVELOPMENT, INC**, (hereinafter referred to as the "Nonprofit").

**ARTICLE II. PURPOSE**

The purpose and object of the Nonprofit shall be to teach and spread the principals of good citizenship and community responsibility. The Nonprofit shall also conduct any and all Business consistent with the laws of the State of Florida and United States of America.

**ARTICLE III. PRINCIPAL PLACE OF BUSINESS**

The principal place of business of this corporation shall be 5133 Soutel Drive, Jacksonville, Florida 32208.

**ARTICLE IV. TERM OF EXISTANCE**

Commencing on November 3, 2000, the Nonprofit shall have perpetual existence.

**ARTICLE V. MEMBERSHIP**

Pursuant to the By-Laws, membership in, and services offered by the Nonprofit are open to all individuals, on a non discrimination basis, who accept principals of good citizenship and community responsibility.


