# ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

## ARTICLE I

The Name of this corporation shall be:

The Advent Hope Youth Foundation Inc.

## ARTICLE II

The principal place of business and mailing address of the corporation shall be:

The AHYF Inc. P. O. Box 1211 Hawthorne, FL 32640

## ARTICLE III

The purpose for which the corporation is organized is:

- Section 1: The Advent Hope Youth Foundation Inc. is organized exclusively for charitable, religious, scientific, and educational purposes as set forth in Section 501C (3) of the Internal Revenue Code including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501C (3) of such code.
- Section 2: The specific purpose of The Advent Hope Youth Foundation Inc. is to promote and provide spiritual, educational, and professional opportunities for young people in areas where the use of their gifts, talents, energies, and education may be applied to developing ways to relieve the poor, the sick, the starving, the underprivileged, and humanity at large by using the avenues of science, research, education, business, faith, and public health in general.
- Section 3: No part of the net earnings of The Advent Hope Youth Foundation Inc. shall inure to the benefit of, or be distributable to its directors, officers, or other private persons, except that The Advent Hope Youth Foundation Inc. shall be authorized and empowered to pay competitive compensation for services rendered as well as make payments and distributions in furtherance of the purposes set forth in these Articles of Incorporation.
- Section 4: No substantial part of the activities of The Advent Hope Youth Foundation Inc. shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and The Advent Hope Youth Foundation Inc. shall not participate in, or intervene in (including the

publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

Section 5: Notwithstanding any other provision of these Articles, The Advent Hope Youth Foundation Inc. shall not carry on any other activities not permitted to be carried on ( a ) by a Corporation exempt from federal income tax under Section 501C(3) of the Internal Revenue Code, ( b ) by a Corporation, contributions to which are deductible under section 170C(2) of the Internal Revenue Code, or ( c ) by a nonprofit Corporation organized under the laws of the state of Florida.

Section 6: The general powers of The Advent Hope Youth Foundation Inc. shall include the power to receive and administer funds for the aforesaid purposes, and to that end to take and hold by contract, agreement, bequest, devise, gift, purchase, lease, either absolutely or in trust for such objects and purposes of any of them, and property real, personal or mixed, without limitations, if any, as may be imposed by law; to sell, convey, and dispose of any such property and to deal with such property for any of the aforementioned purposes, without limitation, except such limitations, if any, as may be contained in the instrument under which such property is received; and to exercise any, all and every power for which a non-profit Corporation organized under the provisions of the state of Florida, all for the public welfare can be authorized to exercise, but not any other power.

#### ARTICLE IV

The manner in which the directors are elected or appointed:

The manner in which the Board of Directors of The Advent Hope Youth Foundation Inc. shall be chosen and removed from office, their qualifications, powers, duties, compensation, if any, tenure of office, the manner of filling vacancies on the Board, and the manner of calling and holding meetings of the Board of Directors shall be stated in the Bylaws.
