Thank you for speaking with me today regarding the dissolution of the corporation for the South East Gilchrist County Volunteer Fire Department.

As I stated, the return of the 2001 Uniform Business Report that I sent in along with a check for \$61.25 was never return to my attention or was there any correspondence received. The report was sent to our ex county attorney's office and I was not made aware of the request for the FEI number.

One of our volunteer fireman was surfing the web and found that we were no longer a corporation. He told me the evening of October 18<sup>th</sup> and I phoned the Division of Corporations first thing Friday morning, October 19<sup>th</sup>. I asked what I needed to do and was told to send the copy of the 2001 Uniform Business Report and a letter stating what had happened and that we would be reinstated. At that time I assumed that we were inactive. I wrote the letter immediately and mailed it out along with a copy of the report and a copy of the cancelled check.

I was not aware that the form had been returned to the ex county attorney's office for the FEI number and as you can see once I was made aware I reacted immediately to the situation and mailed in the appropriate information. We are a small volunteer fire department with a new Board of Directors and I can't tell you how hard pressed we would be if we had to pay the reinstatement fee. I have no recourse with the ex county attorney's office to get this fee.

Please, if there is any way that you can help with this problem it would mean a lot to our fire department. I apologize for this problem and I am amazed that this could happen. Thank you again for your help.
