Articles of Incorporation of the Downtown Ministries of Gainesville, Inc., who are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida.

Article I

The name of the Corporation shall be Downtown Ministries of Gainesville, Inc.

Article II

The initial place in Florida where the principal office of the Corporation is to be located is 13106 NW 19th Place, Gainesville, Alachua County. The Board may choose to relocate the principal office to another site within Alachua County at its discretion.

Article III

Said corporation is organized exclusively for the charitable purposes of providing free meals to the poor, the distressed, and the underprivileged persons of Gainesville, and including such charitable purposes as making distributions of free clothing and household goods as have been donated to the Downtown Ministries of Gainesville, Inc.

Article IV

The business affairs of the Downtown Ministries of Gainesville, Inc. shall be managed by its Board of Directors, which may exercise all corporate powers not specifically prohibited by statute, by the certificate of incorporation, or the bylaws. Members of the Board are nominated at the January meeting, and if approved by a majority of the existing Board, will serve on a voluntary basis for a one year term.

Article VII

The incorporator for the Downtown Ministries of Gainesville, Inc. will be Terrence
J. Brannan, 13106 NW 19th Place, Gainesville, FL 32606.

Article VIII

Should this corporation be dissolved, any remaining assets shall be distributed to
The Bread of the Mighty Food Bank; Gainesville Community Ministries; or any
local charitable organizations that have Internal Revenue Service 501C3
designation. Distributions shall be in percentage to the contributions made during
the previous 12 months. No individual shall receive any assets from this
dissolution.

Having been named as registered agent to accept service of process for the above state
corporation at the place designated in this certificate, I am familiar with and accept the
appointment as registered agent and agree to act in this capacity.
