ARTICLES OF INCORPORATION
OF
TNT BOXING CLUB II, INCORPORATION

We, the undersigned subscribers to these Articles of Incorporation, each a natural person, competent to contract, hereby make, subscribe, acknowledge and file these Articles for the purpose of becoming a Corporation not for profit pursuant to chapter 617.0202, Florida Statutes.

ARTICLE I: NAME

The name of the corporation shall be TNT Boxing Club II, Inc.

ARTICLE II: PLACE OF BUSINESS

The principal place of business shall be in the County of Hillsborough, State of Florida as determined by the Board of Directors. The mailing address is: 2410 Cypress Street, #A, Tampa, Florida 33607.

ARTICLE III: PURPOSE

The organization is organized exclusively for charitable, religious, educational, and/or scientific purposes under section 5019(c)(3) of the Internal Revenue Code. The organization organized as follows:

1. To provide a meaningful outlet for at-risk children to have an opportunity to developed personal skills and sportsmanship.
2. To develop amateur inter-regional competitions amongst at-risk kids.
3. To provide mentoring, tutoring and outreach programs.
4. To develop a partnership with other community agencies to enhance boxing, discipline and self-awareness training for at-risk kids.

ARTICLE IV: BOARD OF DIRECTORS

The Board of Directors shall consist of not less than five(5) and no more than eleven(11) individuals from the community.

The Board of Directors shall be elected at the annual meeting of the directors and each director shall hold office for a term of three(3) years and until his or her successor is duly elected and qualified or until his or her death, resignation or removal.

Each person named in the Articles of Incorporation as a member of the initial Board of Directors shall hold office for an initial term of two(2) years and until his or her

successor shall have been elected and qualified or until his or her earlier resignation, removal from office or death.

ARTICLE V: BASIS OF OPERATION

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE VI: DISSOLUTION

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.

ARTICLE VII: REGISTERED AGENT

The registered agent of this corporation shall be Karima Askew, 2410 Cypress Street, #A, Tampa, Florida 33607.

ARTICLE VIII: TERM OF EXISTENCE

This corporation not for profit shall have perpetual existence.

ARTICLE IX: OFFICERS

The officers of the Corporation shall be the President, Vice-President, Secretary and Treasurer and other officers as provided by the By-Laws.

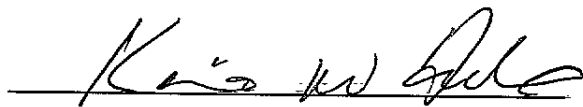
ARTICLE X: BY-LAWS

The By-Laws of this corporation shall be made by the Board of Directors and may be amended or rescinded as provided therein.

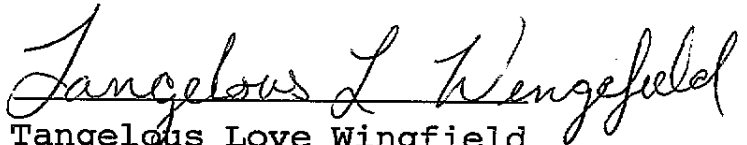
The latest edition of Roberts Rules of Order shall govern all proceedings of the corporation when not covered by the By-Laws.

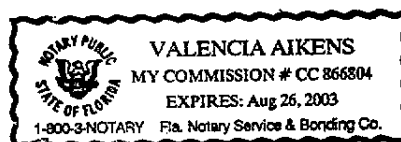
