ARTICLES OF INCORPORATION

The undersigned, acting as Incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I
NAME

The name of the non-profit Corporation (hereinafter referred to as the Club) shall be the DOMINICAN SPORTING AND CULTURAL ASSOCIATION, "LOS QUISQUEYANOS", INC.

ARTICLE II
PRINCIPAL OFFICE

The location of this corporation shall be at 2320 S.W. 60 Terrace, 2nd Floor, Miramar, FL 33023.

ARTICLE III
PURPOSE

The Corporation is organized and operating for social and recreational purposes within the meaning of Section 501(c)(7) of the Internal Revenue Code, and as subsequently amended. The nature of the activities to be conducted and the purpose to be promoted and carried out are as follows: To primarily promote interest in sports, complemented with cultural, social, and recreational activities and to encourage their safe and skillful operation by developing, arranging, and regulating all forms of sports competition, by dissemination of information through Club publications and news releases; and through related cultural, social, and recreational activities for the instruction and enjoyment of its members, all within the meaning of Section 501(c)(7) of the Internal Revenue Code

ARTICLE IV
MANNER OF ELECTION

The manner in which the directors are elected or appointed are set forth in the bylaws of this corporation.

ARTICLE VI
LIMITATIONS OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, subject to the following limitations:

No part of the net earnings of the corporation shall inure to the benefit of any private individual. Upon dissolution, all assets of the corporation will be distributed to organizations exempt under Internal Revenue Code section 501 (c) (3). Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE VII
INDEMNIFICATION

The Board of Directors of the club is authorized, regardless of the adverse interest of any or all of the Board of Directors, to indemnify and reimburse, at Club expense, any person made a party to any action, suit, or proceeding by reason of the fact that he or a person whose legal representative or successor he is, is or was a Director, Officer, or employee of the Club, for expenses, including attorneys fees and such amount of any judgment money decree, fine penalty, or settlement for which he may have become liable as the Board of Directors deems reasonable settlement of any such action, suit or proceeding, or any appeal therein, except in relation to matters as to which he, or such person whose legal representative or successor he is, is finally adjudged in such action, suit or proceeding, to be liable of negligence or misconduct in the performance of this duties.
