# **Articles of Incorporation** Mt. Sinai Holy Temple #2 Inc.

CONDITION OF THE PARTY OF THE P

The undersigned Incorporator for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

#### Article I

The Name of the Corporation shall be Mt. Sinai Holy Temple #2, Inc

#### Article II

The period of duration of the corporation shall be perpetual.

### Article III

The purpose for which this corporation is organized is to be a Church to share Christ through his spoken word, and to spread the gospel in outreach ministries.
