## AMENDMENT TO ARTICLES OF INCORPORATION OF VILLA VISTOSA CONDOMINIUM ASSOCIATION, INC.,

a Florida non-profit corporation

This Amendment to Articles of Incorporation of Villa Vistosa Condominium Association, Inc., a Florida non-profit corporation, was duly adopted by unamimous written consent of the Members of Villa Vistosa Condominium Association, Inc., on the 11 day of 12 day of 2004. [Underlined text is added; stricken text is deleted]

1. Section 4.3 of Article V is amended as follows:

Section 4.3 The owner(s) of each unit shall be entitled to one (1) vote as a member of the Association. The manner of exercising voting rights shall be determined by the Bylaws of the Association. To the extent permitted by law, every member entitled to vote shall be entitled to accumulate his or her votes and to give one candidate a number of votes equal to the number of votes he or she could give if one director were being elected multiplied by the number of directors to be elected or to distribute such votes on the same principles among any number of such candidates.
