WOMEN TO WOMAN WORLDWIDE OUTREACH MINISTRIES, INC. the undersigned natural person of the age of eighteen years or older, acting as incorporate for the purpose of creating a non corporation under the laws of the State of **FLORIDA** as contained in **ARTRICLE** OF CORPORATION_(STATUE) entitled "Non Corporation Act," and the general amendments thereto, do hereby set forth:

Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.
- f. No part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation, or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.
