WOMEN TO WOMAN WORLDWIDE OUTREACH MINISTRIES, INC. the undersigned natural person of the age of eighteen years or older, acting as incorporate for the purpose of creating a non corporation under the laws of the State of FLORIDA as contained in ARTICLE OF CORPORATION (STATUE) entitled "Non Corporation Act," and the general amendments thereto, do hereby set forth:

1. The name of the corporation is
2. The corporation is a RELIGIOUS (religious, charitable, etc.) corporation.
3. The purposes for which the corporation is organized are:
 - a. TO MINISTER AND PROVIDE SERVICES TOO BROKEN HEARTED, ABUSED, WOMEN, CHILDREN AND TEEN MOTHERS FROM ALL AREAS. SUCH AS DRUGS, AIDS, DOMESTIC VIOLENCE AND PROVERTY.
 - b. TO PROVIDE CHRISTIAN COUNSELING, THERAPY ALONG WITH MENTAL HEALTH SERVICES FOR THE EMOTIONLLY AND PHYSICALL WOUNDED WOMEN AND CHILDREN. TO PROVIDE A SAFE HAVEN FOR PROFESS WOMEN AND WOMEN OF PROVERTY. TEACHING WOMEN ABOUT INDEPENDENT LIVING, HOW TO SAVE AND INVEST, HOW TO OWN YOUR OWN BUSINESS. MAKING THE COMMUNITY AWARE OF DOMESTIC VIOLENCE THROUGH SEMIARS, WORKSHOPS AND CONFERENCE AND IN HOME VISITS.
 - c. TO PROVIDE AN OUTREACH MINISTRY TO THE COMMUNITY, SHELTER, DENTIONS CENTERS, SUBSTANCE ABUSE AGENCY JAILS AND PRISIONS.

d. The purpose for which WOMEN TO WOMAN OUTREACH WORLDWIDE MINISTRIES, INC. is organized are exclusively religious, charitable, and/or educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

e. Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

f. No part of the activities of the corporation shall be carrying on propaganda, or otherwise attempting to influence legislation, or participating in, or intervening in (including the publication or distribution of statements), any political campaign on behalf of any candidate for public office.

4. The corporation shall have members which may be divided into such classes as shall be provided in the bylaws. All members shall be accepted, appointed, elected or designated in the manner provided in the bylaws.

5. The directors of the corporation shall be elected or appointed in the manner and for the terms provided in the Bylaws.

6. No part of the net earnings of the corporation shall inure to the benefit of any officer, director or member of the corporation; and upon the dissolution of the corporation, the Board of Directors shall, after paying or making provision for payment of all the liabilities of the corporation, dispose of the residual assets of the corporation exclusively for the stated purposes of the corporation in such manner, or to one or more organizations which themselves are exempt as organizations described in Sections 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1986 or corresponding Sections of any future Internal Revenue Code. Any such assets not so disposed of shall be disposed of by the Superior Court of the county in which the principal office of the corporation is then located, for such purposes or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
