ARTICLES OF INCORPORATION
of Friends of Lake Griffin, Inc.

ARTICLE I

Name

The name of the corporation shall be: Friends of Lake Griffin, Inc.

ARTICLE II

Principal place of business and mailing address

The initial mailing address of association shall be 10111 SE US Hwy 441, Belleview FL 34420.

The principal office of association shall be located at the mailing address or at any other place as may be subsequently designated by the board of directors of association.

ARTICLE III

Purposes

The specific purposes for which this corporation is organized is are: To promote the environmentally responsible use of Lake Griffin and surrounding areas located in Lake County Florida. To protect and preserve the environment of Lake Griffin and surrounding areas. To promote the common good and general welfare of the residents surrounding Lake Griffin. To promote, create, establish, organize, produce, own, control, display, conduct and manage any and all types, kinds and classes of knowledge, arts, sciences, public recreation, sporting, athletic, skilled, artistic, educational and esthetic exhibitions, contests, games, performances, enterprises, productions, pageants and other attractions for the development and advancement of Lake Griffin and surrounding environs without pecuniary profit to the individual members of the corporation.

ARTICLE IV

Manner of election of directors

The manner in which the directors are elected or appointed is as follows: The minimum number of directors will be not less than three. The initial directors will be selected by vote of interested parties who attend the initial organizational meeting.

Directors as Membership. The sole class of members of this corporation shall be its directors.

Rights and Liabilities of Members. The members of this corporation shall have no right, title, or interest in its income, property, or assets, nor shall any portion of its income, property, or assets be distributed to any member on the dissolution or winding up of this corporation. Members of this corporation shall not be personally liable for the debts, liabilities, or obligations of the corporation, and shall not be subject to any assessments.

The directors will hold meeting not less than annually. The directors may adopt bylaws that will govern the corporation, and the directors may also appoint officers of the corporation.

ARTICLE V

Limitation of corporation powers

The corporate powers of this corporation are as provided in FS §617.0302.

ARTICLE VI

Initial registered agent and street address
