Thank you for your assistance by telephone on Monday, July 30, 2001.

As per your advice I am writing this letter to establish that I am not now, nor have I ever been the president of Melchizedek Ministries, Inc. I am not a member of that organization and am in no way associated with William G. Hardin, (on your documents it is spelled "Harding" but the man I have met refers to himself as "Hardin"). I am unacquainted with Mr. Dominick Marchiano, whose name also appears on the State of Florida's web site concerning corporations (on the page referring to Melchizedek Ministries, Inc.)

I believe that by listing my name as president, Mr. Hardin has perpetrated a deliberate fraud and is using this listing as a corner stone for other fraudulent acts. Enclosed, you will find a copy of a letter that was notarized and sent to Mr. Hardin on 5/4/01 and a letter from him in response.

I am pursuing other legal avenues as well but for now I am enclosing a \$35 check (as per your instructions) in order to have this document made part of your official package for Melchizedek Ministries, Inc. and to have my name removed from this organization's corporate listing.

If you can think of any other legal recourse I can take to further prove that I have *never* been the president of said organization please let me know at your earliest convenience as I am most anxious to end this man's use of my name and reputation as well as to show my lack of culpability for his actions.

Dear Glenn:

A few weeks ago, on a Tuesday, you approached me in the driveway of my home and asked that I become the president of Melchizedek Ministries. You handed me a credit card with my name embossed on it and your signature on the back. You also gave me a book, which you explained was a gift for my wife.

I hadn't agreed to have a credit card issued in my name, so it came as something of a surprise, but as I was entering my car when you arrived and as I was leaving for another engagement, I couldn't take the time to discuss it properly.

We were to meet the following Friday, and although I set the day aside, you did not reappear, nor did you call to cancel the engagement. I am told that a week later you did call, but I was away with guests and had long since surmised that as you did not keep the previous appointment, your offer was withdrawn. In any case I had already decided to refuse your offer as I am extraordinarily busy with my own projects as I mentioned during our brief encounter in my driveway. Further, my wife Margaret who is not only my life partner, but my business partner as well has been and remains vehemently opposed to any liason between our company and yours. Thus it would be quite impossible to proceed in any venture under such circumstances. I was surprised to discover that you forged my signature on the documents for the Orangebee Private Money, Inc. and listed me as president of Melchizedek Ministries. You also signed my name to a check for \$395 for "Membership dues" made out to Orangebee Private Money, Inc.

Glenn, I am not the president of your organization. I have no interest in being a member of Orangebee Private Money, Inc., and quite frankly I am most concerned that my name has now appeared on these documents of which I had no knowledge and for which I gave no authorization.

Therefore, please consider this to be a letter of request for you to cease and desist any further use of my name, my company name, my social security number or any reference to me or my organizations.

I would also like to know of any other times or places where you have used my name or forged my signature, as it could prove to be potentially embarrassing for either one or both of us should other agencies step forward to inform me of unauthorized use of my name, credit or standing in the community.

I will be sending copies to the Florida Division of Corporations and so there will be no legal misunderstandings in the future, I will create a copy for my attorney as well.

I hope you find good fortune. I am told you believe this whole incident to be a misunderstanding, so I will add that I cannot permit my family, my company or myself to be placed in jeopardy by the business dealings of another. It has been suggested that to have used my name, my social security number and to have fabricated my signature is not only wrong, but actionable. I trust you will not repeat this error in judgment.
