The undersigned incorporator, for the purpose of forming a corporation under the Florida Not For Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the Corporation is CRUSADE FOR LUNG CANCER AWARENESS, INC.

ARTICLE II - INITIAL PRINCIPAL OFFICE

The address of the initial principal office of the Corporation is 1525 Highcrest Circle, Valrico, Florida 33594.

ARTICLE III - PURPOSE

The purposes for which the Corporation is organized are: To promote public awareness of lung cancer; to advocate for increased funding for lung cancer research; to offer support and education to lung cancer patients and their families.

ARTICLE IV - DIRECTORS
