The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a Corporation under the laws of the State of Florida.

ARTICLE I, NAME

The name of the Non-Corporation shall be: **LONGORIA FARM WORKER'S VILLAGE CAMP, INC.**

ARTICLE II, PRINCIPAL PLACE OF BUSINESS

The principal place of business and mailing address of the Non-Profit Corporation is:
State Road 82 and Teter Road Fort Myers. Florida 33905 (Permanent Address)
9070 Laredo avenue Fort Myers, Florida 33905 (Mailing Address)

ARTICLE III, NATURE/PURPOSE OF BUSINESS

The organization will renovate and maintain decent and suitable residential migrant farm housing units for farm workers and their families. The multifamily duplex units will be leased at below-market rents to seasonal farm workers, both related and unrelated groups. The special housing needs of those hired farm workers who work intermittently from farm to farm as work is available and are having the most difficulty finding adequate housing year-round in Lee County will be given priority attention. These vital accommodations will conform to current code enforcement requirements.

ARTICLE IV, ADDRESS

ARTICLE V. NAME OF REGISTERED AGENT

ARTICLE VI. TERM OF EXISTENCE

This Non-Corporation is to exist in perpetuity.

ARTICLE VII. MANNER OF ELECTION OF DIRECTORS

The Corporation shall have four (4) directors initially. The Directors shall be elected at the end of each calendar year. The name and street address of the initial member(s) of the Board of Directors are:

- 4) **Norma Longoria – Secretary – 4716 Nuttingham Drive Fort Myers, Florida 33905**

The individual Directors of the Corporation shall not be liable to the Corporation of shareholders for monetary damages for breach of duty of care, or of other duty as Director, provided that nothing herein shall limit the liability of any Director.

- A. For any appropriation in violation of his duties, of any business opportunity of the Corporation.
- B. For acts or omissions which involve intentional misconduct of knowing violations of laws.
- C. For any transaction from which the Director received an improper personal benefit.
- D. For any distribution violating Florida Business Corporation Code failure to act in good faith for the best interests of the Corporation, or for failure to exercise the care an ordinary prudent person would exercise under similar circumstances.

- A. The organization is organized exclusively for charitable, religious, educational, and/or scientific purposes under section 501 (c) (3) of the Internal Revenue Code.
- B. Not part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried out on a (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- C. Upon the dissolution of the organization, assets shall be distributed from one of more exempt purposes within the meaning of section 501 (2) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
