ARTICLES OF INCORPORATION
OF
COCONUT CREEK JEWISH PUBLIC LIBRARY INCORPORATED
A Florida Not-for-Profit Corporation

In compliance with Chapter 617 of the Florida Statutes:

ARTICLE I: NAME

The name of the corporation shall be Coconut Creek Jewish Public Library Incorporated.

ARTICLE II: PRINCIPAL OFFICE

ARTICLE III: PURPOSE
