**ARTICLES OF INCORPORATION**

In compliance with Chapter 617 of the Florida Statutes:

**ARTICLE I: NAME**

The name of the corporation shall be Chabad House Library of North Palm Beach Incorporated.

**ARTICLE II: PRINCIPAL OFFICE**

**ARTICLE III: PURPOSE**
