ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I

Name, Duration and Effective Date

The name of the Corporation is Countryside Baptist Church of Lake Mary, Inc.
The duration of the corporation is perpetual. The effective date upon which this corporation shall come into existence shall be November 1, 2000.

ARTICLE III

Corporate Purposes

The specific purposes for which this corporation is organized are:

- A. This congregation is organized as a church exclusively for charitable, religious, and educational purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue Law), including, but not limited to, for such purposes, the establishing and maintaining of religious worship, the building, maintaining and operating of churches, parsonages, schools, chapels, radio stations, television stations, rescue missions, print shops, day-care centers, camps, and nursing homes.
- B. The church shall also ordain and license men to the Gospel ministry; evangelize the unsaved by proclaiming of the Gospel of the Lord Jesus Christ; educate believers in a manner consistent with the requirements of Holy Scripture, both in Sunday and weekday schools of Christian education; and maintain missionary activities in the United States and any foreign country.

ARTICLE IV

Manner of Election of Directors

The manner in which the directors are to be elected is by a majority vote of congregation members.


