<u>ARTICLE I</u> - NAME

The name of this Corporation shall be: WECAM FOUNDATION, INC., a corporation not for profit.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - PURPOSE

ARTICLE IX - DISSOLUTION

Upon the dissolution of the corporation, The Board Directors shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c) (3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the Circuit Court of the County in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
