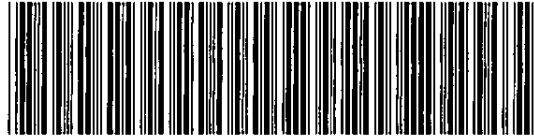

scriptural mandate. The Apostle Paul writes to them at Rome and describes an  
unacceptable condition as he writes: "...their women exchanged natural  
intercourse for unnatural intercourse, and the same way also the men, giving up  
natural intercourse with women, were consumed with passion for one another.  
Men committed shameless acts with men and received in their own persons  
the due penalty for their error." (Romans 1:26b - 27 NRSV).


