ARTICLES OF INCORPORATION

In Compliance with Chapter 617.0202, F.S. (Not for Profit)

ARTICLE I: The name of the non-profit corporation shall be SOUTH FLORIDA ASSOCIATION OF RABBIS, INC.

ARTICLE II: The principal place of business and mailing address of SOUTH FLORIDA ASSOCIATION OF RABBIS, INC. shall be 9561 CYPRESS PARK WAY, BOYNTON BEACH, FL 33437-2108.

ARTICLE III: The purpose for which SOUTH FLORIDA ASSOCIATION OF RABBIS is organized is to provide a professional organization of rabbis who are dedicated to the preservation of the higher values of Jewish spiritual and ethical leadership, who are committed to the proliferation and development of Jewish religious and cultural traditions, and who seek to foster group reinforcement through education, the open exchange of ideas, and mutual spiritual and emotional support.

ARTICLE IV: The manner in which Directors are elected and appointed is that they shall be initially appointed in the Articles of Incorporation and may serve staggering terms of office which shall number not less than three years, nor more than five years. Said staggered terms shall be apportioned between all the Directors to the extent that one third (1/3) of the Directors shall serve the lesser term; another one third (1/3) of the Directors shall serve the greater term of five years. The term of office each Director shall initially serve shall be fixed by majority vote of the Directors.

The Directors shall hold office until the expiration of their respective terms of office and until their successors have been elected and qualified, unless sooner removed by death, resignation, disqualification or otherwise. The election of Directors to fill the expired terms of any Directors shall be held at an annual meeting by the incorporator.

ARTICLE V: The names of the Initial Directors and Officers are as follows:




