The undersigned subscriber to these Articles of Incorporation, a natural person authorized to contract, hereby adopts the following Articles of Incorporation for the purpose of forming a not-for-profit corporation under Chapter 617, Florida Statutes.

ARTICLE ONE - NAME

The name of the Corporation is Tampa Youth Sports Training, Inc.

ARTICLE TWO - ADDRESS OF PRINCIPLE OFFICE

The initial street address and mailing address of the Corporation's principle office is 9887 Fourth Street North, Suite 200, St. Petersburg, Florida 33702..

ARTICLE THREE - DURATION

The term of existence of the Corporation is perpetual.

ARTICLE FOUR - PURPOSE

The principal objectives and purposes for which this Corporation is organized are as follows:

- To provide assistance and training to youth sports coaches, administrators and youth leagues in developing and fostering leadership, discipline and athletic training
- To provide training programs and camps for youth athletes
- To provide activities and events for youth participation including a youth sports award banquet and a community family "fun day"
- For charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under

Section 501(c)(3) of the Internal Revenue Code, as amended (or the corresponding provisions of any future United States Internal Revenue Code) and have the proposes set forth above. Notwithstanding any other provision contained herein to the contrary, the Corporation shall not carry on any activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 503(c)(3) of the internal Revenue Code, as amended (or the corresponding provision of any future United States Internal Revenue Code).

ARTICLE FIVE - BOARD OF DIRECTORS

The method of appointment, election or removal of Directors shall be stated in the bylaws. The names and street addresses of the three (3) initial Directors of the Corporation are as follows:

ARTICLE SIX - INCORPORATORS

The name and street address of the incorporator is Freddie Solomon, 803 Turtle River Court, Plant City, Florida 33567.

ARTICLE SEVEN - LIABILITY

None of the directors or officers of the Corporation shall be personally liable for its debts, liabilities or obligations.

ARTICLE EIGHT - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this not-for-profit Corporation is 9887

4th Street North, Suite 200, St. Petersburg, Florida 33702 and the name of the initial registered agent of the Corporation at that address is Anthony J. Parrino.

ARTICLE NINE - DISSOLUTION OF THE CORPORATION

Upon dissolution of the Corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the Corporation, dispose of all the assets of the Corporation exclusively for the purposes of the Corporation in such a manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or specified purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 19986, as amended (or the corresponding provision of any future United States Internal Revenue Code), as the Board of Directors shall determine. Any such assets not disposed of shall be disposed by a Court of general jurisdiction in the county in which the principle office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusive for such purposes.

ARTICLE TEN - NO STOCK TO BE ISSUED

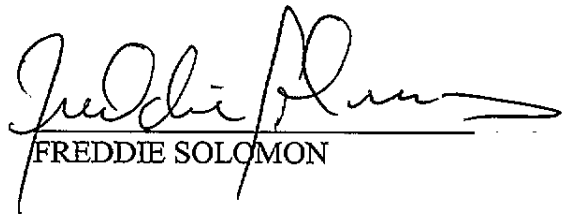
The Corporation is organized on a non-stock basis. The Corporation shall not issue any stock.

ARTICLE ELEVEN - NO PRIVATE INUREMENT

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or their private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Four hereof. No substantial part of the activities of the Corporation shall be the carrying

on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidates for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Code) or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986, as amended (or the corresponding provision of any future United States Internal Revenue Code).

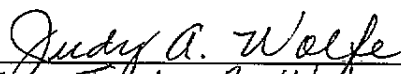

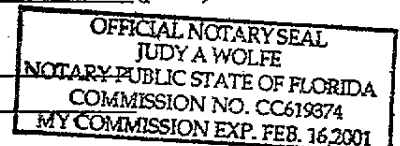

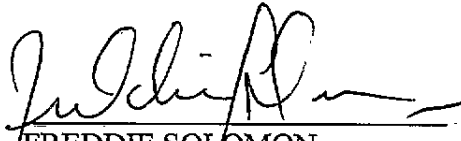
