The manner in which the director will be selected will be by election of the corporation officers and he/she will serve a term of two years unless otherwise specified by the corporation officers.

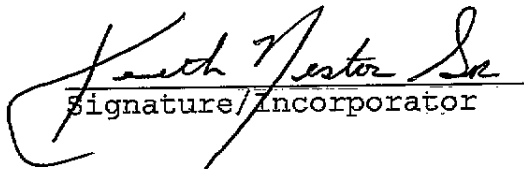
ARTICLE V INITIAL DIRECTORS/OFFICERS
