CERTIFICATE OF INCORPORATION OF CENTRAL FLORIDA N-TENSITY SOFTBALL, INC.

ARTICLE I Name

The name of the Corporation is Central Florida N-Tensity Softball, Inc.

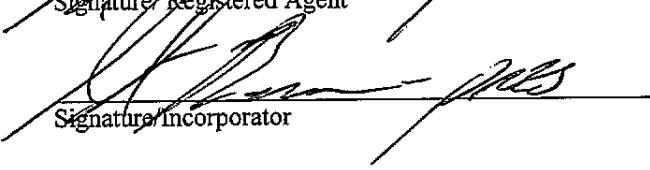
