## Articles of Incorporation

For

### Citizens Against Juniper Creek Dump, Inc.

*The undersigned Incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:*

#### Article I

The name of the Corporation shall be: Citizens Against Juniper Creek Dump, Inc.

#### Article II

The principal place of business and mailing address of this corporation shall be:

#### Article III

The specific purpose for which the corporation is organized is for the Citizens of Okaloosa County, Florida, who own real property adjacent to a landfill proposed to be constructed 2,400 feet east of Hart Road (Campbell's Circle Road) and State Road 85 intersection, Campton, Okaloosa, Florida, and Citizens of Okaloosa County who own and are in close proximity to said landfill and of the county who are opposed to the said landfill because of its adverse impact on the natural environment. The purpose of Citizens Against Juniper Creek Dump, Inc., is to preserve the quality of the natural environment and to oppose the construction of the aforesaid proposed landfill, the

construction of which would violate Okaloosa County Comprehensive Growth Management Plan and would pose an unreasonable and unacceptable hazard to the quality of the natural environment including pollution, flooding and deterioration of water quality with respect to the real property adjacent to and in the area of the subject land fill in Okaloosa County, Florida.


