The undersigned, desiring to organize a Not for Profit organization for the Purposes hereinafter listed, pursuant to the Not for Profit Act and other laws of the State of Florida, hereby certifies as follows:

ARTICLE I – NAME

The name of the corporation is Survivors of Domestic Abuse, Inc. (the "Corporation").

ARTICLE II – PRINCIPAL OFFICE

ARTICLE III – PURPOSE

The general nature of the business to be transacted at the corporation shall be:

- (a) To engage in every phase of protection for the victims of Domestic Abuse. Lobbying under the laws of the State Of Florida to get laws enforced to help give the victim more protection from law enforcers.
- (b) To buy land and build a safe place for victims to regain control of their lives. Such facilities shall be offered to the victim until he or she is stable enough to regain personal finances and mental stability. We shall also hire licensed professionals to render professional psychological services in effort to help the victim-overcome circumstances that may cause repeat abuse. Such professional services shall be rendered only through officers, employees, and agents who are dully licensed or otherwise legally authorized to render such professional services in the State of Florida under the laws of the State of Florida.
- (c) To invest the funds raised to buy real estate mortgages stocks, bonds, or any other type of investment, necessary for the rendering of services needed to the victims of Domestic Abuse.

- (d) To do anything necessary and proper for the accomplishment or furtherance of any of the purposes or attaining any of the objectives enumerated in these Articles of Incorporation, or any amendment hereto, and to do any necessary or incidental to the protection and benefit of the Corporation, and in general, either alone or in association with other corporations, firms, partnerships, artificial entities, or individuals to carry on any lawful pursuit necessary or incidental to the accomplishment or furtherance of such purposes or objectives of the corporation.
- (e) The Corporation shall have all the powers which are now or which hereafter may be conferred upon Non Profit Organizations by the laws of the State of Florida.

ARTICLE IV - MANNER OF ELECTION

The corporation shall have Three (3) Directors initially. The numbers may be increased or diminished, from time to time, by the bylaws adopted by the Board members, who will be selected initially by the President of the corporation. All manners in which election of Directors to the corporation will be formed by the Board members after carefully appointing individuals to the Board.
