**ARTICLES OF INCORPORATION**  
**OF**  
**THE N.A.A.C.O. CORPORATION,**  
**(A Nonprofit Corporation)**

**ARTICLE I**  
**NAME**

The name of this corporation shall be the N.A.A.C.O. Corporation.

**ARTICLE II**  
**DURATION**

The duration of this corporation shall be perpetual.

**ARTICLE III**  
**PURPOSES**

This corporation is formed as a nonprofit corporation under the laws of the State of Florida, for charitable, educational, religious, and associational purposes.

In the belief that there is a large population of persons, both married, and single, who believe themselves to be moral, loving, caring, and religious people while sharing a belief in their own friendship and sexuality and the friendship and sexuality of their friends, and who believe that the highest form of caring is the sharing of that friendship and sexuality, we propose to create a private membership only organization which will be open to any persons who desire to live an alternative lifestyle, are currently living an alternative lifestyle, or to those that are accepting and supportive of those persons living such alternative lifestyles, and which will provide a safe, loving, caring environment for the physical, emotional, religious and spiritual growth of people that share this belief.

This organization is formed for purposes within the scope of Section 501 (c) (3) of the U.S. Internal Revenue Code, and any activities prohibited by that section are prohibited to this organization and its authorized agents.

**ARTICLE IV**  
**MEMBERSHIP**

This corporation shall have members, upon such conditions and terms as may be established by the board of directors.

**ARTICLE V**  
**BOARD OF DIRECTORS**

The initial board of directors shall be the incorporators. The number of directors shall be three. Successors to directors shall be elected by a plurality of the board at a meeting at which there is a quorum.

**ARTICLE VI**  
**PRINCIPAL OFFICE**

The Principal office of the corporation shall be at 4200 Southeast 41st avenue, Ocala, Florida, 34480. The mailing address of the Corporation shall be: N.A.A.C.O. Post Office Box 5332, Ocala, Fl. 34478

**ARTICLE VII**  
**AMENDMENTS**

These articles may be amended by a vote of a majority of the board of directors, upon 30 days notice to all directors. Recognizing that an amendment is important, the majority requirement means a majority of all directors then duly selected and sitting.

**ARTICLE VIII**  
**MEETINGS**

Meetings of the board of directors shall be convened at least semi annually.

**ARTICLE IX**
