ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S. (Not for Profit)

ARTICLE I. NAME

The name of the corporation shall be: Florida Administrators of Volunteers In Government, Inc.

ARTICLE III. PURPOSE

The purpose for which the corporation is organized is to improve the use and management of volunteers in governmental agencies whether it is Federal, State, County, or City. The organization will accomplish this goal by actively marketing volunteer citizen support in governmental agencies; promoting the sharing of information between agencies about the management of volunteers; providing training for administrators and staff who manage volunteers; and conducting research into relevant issues concerning governmental volunteers.

ARTICLE IV. MANNER OF ELECTION

Prior to each Annual meeting, the President shall appoint a nominating committee composed of three (3) members of the Association. The members of the committee shall be appointed from those persons who have exhibited knowledge of the Association and its goals, leadership within the Association, and representation within the diverse segments and areas of the Association. The President shall appoint one member of the committee to serve as chair.

The Nominating Committee's recommendations shall serve as a nomination for each officer. At the Annual meeting, the President shall ask for any additional nominations from the floor for each office. Once nominations are made, the election shall be held. Nominees for each office receiving a majority of votes by ballot shall be declared elected.
