ARTICLES OF INCORPORATION

The undersigned acting as incorporator(s) of a Corporation pursuant to Chapter of Florida Statues, adopt(s) the following Article of Incorporation of such corporation:

ARTICLE I

The name of the corporation shall be:

ARTICLE II
