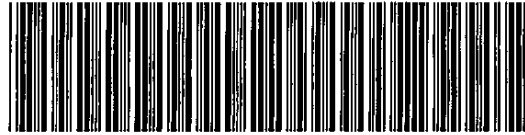

ARTICLE III - CONTINUATION

PREAMBLE:

"THIS CORPORATION, THE ROMANIAN ORTHODOX CHURCH - ARCHANGELS MICHAEL AND GABRIEL, INC. FROM ADOPKA 1809 SHEELER RD, FL 32703 - SUBMITS ITSELF TO THE ADMINISTRATIVE AND CANONICAL JURISDICTION AND SUPERVISION OF THE ROMANIAN EPISCOPATE OF AMERICA, HAVING ITS HEADQUARTERS LOCATED IN THE TOWNSHIP OF GRASS LAKE, JACKSON COUNTY, STATE OF MICHIGAN. THE CORPORATION FURTHER ACCEPTS TO GOVERN ITSELF ACCORDING TO THE CONSTITUTION AND BY-LAWS OF THE SAID ROMANIAN ORTHODOX EPISCOPATE OF AMERICA AND TO CONDUCT AND MANAGE ITS AFFAIRS IN ACCORDANCE WITH THE SAID BY-LAWS."

ARTICLE I

THE PARISH IS A LOCAL COMMUNITY OF THE CHURCH UNDER THE JURISDICTION OF THE ROMANIAN ORTHODOX EPISCOPATE OF AMERICA, HAVING AN APPOINTED PRIEST WHO AS SPIRITUAL LEADER COOPERATIVELY ADMINISTERS THE PARISH WITH THE PARISH COUNCIL WHICH HAS BEEN DULY ELECTED BY ITS PARISH GENERAL ASSEMBLY.

ARTICLE II

THE MAIN PURPOSES OF A PARISH ARE:

a) TO MAINTAIN, STRENGTHEN AND PROPAGATE THE ORTHODOX CHRISTIAN FAITH;

b) TO BUILD AND MAINTAIN BUILDINGS WHERE DUE ORTHODOX WORSHIP IS OFFERED AND TO PROVIDE THE FACILITIES, STAFF AND FUNDING NECESSARY FOR THE RELIGIOUS EDUCATION, CULTURAL AND CHARITABLE NEEDS OF ITS MEMBERS;

c) TO PRACTICE CHRISTIAN CHARITY AS DEMANDED BY HOLY SCRIPTURE AND TRADITION AND TO SEEK OUT AND PROVIDE CHARITABLE ASSISTANCE TO THOSE IN NEED;

THE CHURCH BUILDINGS, FUNDS AND ANY OTHER PROPERTIES OF THE PARISH CAN BE USED ONLY FOR RELIGIOUS, EDUCATIONAL, CHARITABLE

ARTICLES OF AMENDMENT

ARTICLE III CONTINUATION FROM PAGE 2.

ARTICLE III

THE EPISCOPATE CONSTITUTION AND BY-LAWS ARE INCORPORATED INTO THE CORPORATE CHARTER OR ARTICLES OF THE "ROMANIAN ORTHODOX CHURCH - ARCHANGELS MICHAEL AND GABRIEL, INC. FROM 1809 SHEELER RD APOKA FL 32703. IN THE EVENT OF A CONFLICT BETWEEN THE PRESENT OR FUTURE ARTICLES OR BY-LAWS OF THE PARISH AND THE EPISCOPATE'S CONSTITUTION AND BY-LAWS, THE LATTER SHALL BE CONTROLLING.

ARTICLE IV

ACCORDING TO THE ROMANIAN ORTHODOX EPISCOPATE OF AMERICA BY-LAWS "IN THE EVENT OF THE DISSOLUTION OF A PARISH, TITLE TO ALL ITS PROPERTIES, REAL AND PERSONAL, INCLUDING DOCUMENTS, OFFICIAL RECORDS OF BAPTISM, MARRIAGE, BURIAL AND THE LIKE, RELIGIOUS OBJECTS, VESTMENTS, WORKS OF ART, AND ANY OTHER ARTICLES USED IN CONJUNCTION WITH AND FOR THE PURPOSES OF THE PARISH SHALL IMMEDIATELY VEST IN AND PASS TO THE PATRIMONY OF THE EPISCOPATE. (ARTICLE IX, SECTION 10 (a) OF THE BY-LAWS) ONCE THE RESOLUTION TO DISSOLVE IS ADOPTED, IT SHALL BE DEEMED TO CONSTITUTE THE EPISCOPATE DELEGATE AS THE PARISH'S ATTORNEY-IN-FACT WITH FULL AUTHORITY, RIGHT AND DUTY TO CONVEY TITLE OF ALL PARISH PROPERTY TO THE EPISCOPATE, OR ITS DESIGNEE UNDER SECTION 10 OF ARTICLE IX. THE CERTIFIED ASSEMBLY MINUTES, TOGETHER WITH THE BISHOP'S CERTIFICATE OF DELEGATE AND THE BY-LAWS, ARTICLE IX, SECTION 10 AND ARTICLE XIII, SECTION 1, SHALL BE SUFFICIENT FOR FILING WITH REGISTERS OF DEEDS AND ALL OTHER TITLE REGISTRATIONS AUTHORITIES"

ARTICLE V

- a) THE ROMANIAN ORTHODOX CHURCH - ARCHANGELS MICHAEL AND GABRIEL, INC. IS ORGANIZED EXCLUSIVELY FOR CHARITABLE, RELIGIOUS, EDUCATIONAL AND CULTURAL PURPOSES, INCLUDING, FOR SUCH PURPOSES, THE MAKING OF DISTRIBUTIONS TO ORGANIZATIONS THAT QUALIFY AS EXEMPT ORGANIZATIONS UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE.
- b. NO PART OF THE NET EARNINGS OF THE ORGANIZATION SHALL INURE TO THE BENEFIT OF, OR BE DISTRIBUTABLE TO ITS MEMBERS, TRUSTEES, OFFICERS, OR OTHER PRIVATE PERSONS, EXCEPT THAT THE ORGANIZATION SHALL BE AUTHORIZED AND EMPOWERED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED AND TO MAKE PAYMENTS AND DISTRIBUTIONS IN FURTHERANCE OF THE PURPOSE SET FORTH IN THE PURPOSE CLAUSE HEREOF. NO SUBSTANTIAL PART OF THE ACTIVITIES OF ORGANIZATION SHALL BE CARRYING ON OF PROPAGANDA, OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION, AND THE ORGANIZATION SHALL NOT PARTICIPATE IN, OR ~~INTERVENE~~ INTERVENE IN (INCLUDING THE PUBLISHING OR DISTRIBUTION OF STATEMENTS) ANY POLITICAL CAMPAIGN ON BEHALF OF ANY CANDIDATE FOR PUBLIC OFFICE. NOTWITHSTANDING ANY OTHER PROVISION OF THIS DOCUMENT, THE ORGANIZATION SHALL NOT CARRY ON ANY OTHER ACTIVITIES NOT PERMITTED TO BE TO BE CARRIED ON (1) BY AN ORGANIZATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE, OR (2) BY AN ORGANIZATION, CONTRIBUTIONS TO WHICH ARE DEDUCTIBLE UNDER SECTION 170(C)(2) OF INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE.
- c. UPON THE DISSOLUTION OF THE ORGANIZATION, ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE, ACCORDING TO THE ARTICLE
