Dear Pat,

Thank you for taking the time to speak with me on the telephone today. As you suggested, I am appealing the decision to administratively dissolve Zennah Ministries, Inc, as per your Debit Memo # 35589-C.

Allow me to restate the order of events. We received notice that the original check in the amount of \$61.25 did not clear because of insufficient funds. Knowing the consequences of an untimely filing of our UBR, we immediately purchased a Cashier Check in the amount of \$76.25 to pay for the filing fee + the incurred charges for bank fees. As a struggling non-profit agency, we did not want to deal with the issues of dissolution and/or paying a higher fee of \$175.00 for reinstatement. It was clear to us what corrected action was needed to complete our timely filing.

In July, I received a letter concerning the returned check, and filed it away without my copy of the cashiers check attached to it!

Unfortunately, I am unable to produce a copy of the Cashiers check.
I can only give you "my word" that we did comply as requested. We moved our residence during the month of July, (we bought a new house) ... and things were "topsy turvy" then ... so I am sure my copy is misplaced "somewhere" in the shuffle.

Upon speaking with Pat this morning, it was confirmed that you did not receive a check. My only guess, and I know this sounds "lame", is that the check got lost in the mail. I assure you, we "took care of the matter".

My request is that you would please grant us favor, and reinstate us. Enclosed is my personal check in the amount of \$76.25. Should the cashiers check "show up" ... then notify us and we will have it applied to our 2004 filing since it is already made out to you. As I continue to search for our copy, I will fax you a copy when it is found. In the interim, I respectfully request that you reinstate us without penalty, or having to pay the \$175.00 fee. Our ministry is struggling financially, and we are doing the best we can to stop some areas of abuse.

My wife had the privilege of coming to Tallahassee last year to testify before a sub committee of the State House of Representatives. We are doing our best to help others. We are doing our best to conduct our ministry in full compliance of the law. We apologize for any inconvenience this has caused.

I await your reply. Thanking you in advance.
