# CREAR AM BILL ARTICLES OF DISSOLUTION BY DIRECTORS INSTITUTO DE LIDERAZGO EL REY JESUS, INC.

Pursuant to the provisions of Florida Statutes §617.14027 and authorized action of the Board of Directors the following Articles of Dissolution are hereafter adopted by the Board of Directors.

#### Article I
