ARTICLES OF INCORPORATION

FOR

M.O.R.E. Ministries, Inc.

The undersigned, acting as incorporator(s) of a corporation pursuant to chapter Florida statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation shall be:

M.O.R.E. Ministries, Inc.

ARTICLE II: PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business of this corporation is: 4126 57th Avenue, Vero Beach, Florida, 32966.

The principal mailing address of this corporation is: 2120 58th Avenue, Suite 147, Vero Beach, Florida 32966.

ARTICLE III: PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):

1. To provide redemptive ministries for drug and alcohol addicted individuals.
2. To train, educate and equip the drug and alcohol addicted individuals with marketable skills for business and industry.
3. To make an attempt at instilling good social and moral values.
4. To provide guidance that will embrace and enhance social, racial, cultural and ethnic unit.

ARTICLE IV: MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows:

Any vacancy occurring on the board of directors may be filled by the affirmative vote of the majority of the remaining directors, even though the remaining directors constitute less than a quorum, or by the sole remaining director, as the case may be, or, if the vacancy is not filled or if no director remains, by the members, or on the application of any person, by the circuit court of the county where the registered office of the corporation is located.

A director elected or appointed to fill a vacancy shall be elected or appointed for the unexpired term of his or her predecessor in office. Any directorship to be filled by reason of an increase in the number of directors may be filled by the board of directors, but only for a term of office continuing until the next election of directors by the members or, if the corporation has no members or no members having the right to vote thereon, for such a term of office as is provided in the articles of incorporation or the bylaws.

A vacancy that will occur at a specific later date, by reason of resignation effective at a later date or otherwise, may be filled before the vacancy occurs. However, the new director may not take office until the vacancy occurs.

A member may be appointed to the Board of Directors by the President of the Corporation after receiving a majority vote from the board. The names and addresses of the person who are the initial trustees (incorporators) of the corporation are as follows:
