The Church Conference of the First United Methodist Church of Plant City, at meetings called with members entitled to vote and held on February 13, 2001 and November 18, 2001, adopted the following resolution:

"BE IT RESOLVED by the Board of Directors of Plant City United Methodists in Mission, Inc., a Florida corporation, that said Board deems it advisable and hereby declares it to be advisable that Article II and Article VIII of the Certificate of Incorporation be amended, changed, and altered so as to read as follows:

ARTICLE II. PURPOSE

The object, general nature and purpose of this corporation shall be to establish and maintain a center for ministry and social action of the First United Methodist Church of Plant City, subject to the "Book of Discipline" of The United Methodist Church.
