ARTICLES OF AMENDMENT
OF
PLANT CITY UNITED METHODISTS IN MISSION, INC.

Plant City United Methodists in Mission, Inc., a Florida corporation, under its corporate seal and the hands of its President, William Musselwhite, and Secretary, Charlotte Walden, hereby certifies that:

The Church Conference of the First United Methodist Church of Plant City, at meetings called with members entitled to vote and held on February 13, 2001 and November 18, 2001, adopted the following resolution:

“BE IT RESOLVED by the Board of Directors of Plant City United Methodists in Mission, Inc., a Florida corporation, that said Board deems it advisable and hereby declares it to be advisable that Article II and Article VIII of the Certificate of Incorporation be amended, changed, and altered so as to read as follows:

ARTICLE II. PURPOSE

The object, general nature and purpose of this corporation shall be to establish and maintain a center for ministry and social action of the First United Methodist Church of Plant City, subject to the “Book of Discipline” of The United Methodist Church. This church organization shall support the doctrine, and it, and all its property, both real and personal, shall be subject to the laws, usages, and ministerial appointments of The United Methodist Church and the Discipline of said Church. Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VIII. BOARD OF DIRECTORS

The business affairs of this corporation shall be managed by the Board of Directors, which shall consist of not less than three nor more than fifteen persons who shall be elected by the Church Conference of the First United Methodist Church of Plant City as provided for in the “Book of Discipline” and the Bylaws of this corporation.’

IN WITNESS WHEREOF, said corporation has caused these Articles of Amendment to be signed in its name by its President and its corporate seal to be hereunto affixed, attested by its Secretary this 5th day of December, 2001.
