ARTICLES OF INCORPORATION OF

TROOP/PACK 806 - B.S.A., INC.

A Nonprofit Religious Corporation of the State of Florida



The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

- 1. The name of the Corporation is TROOP/PACK 806 B.S.A., INC.
