



The undersigned, acting as incorporator pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation shall be: INTERNET AWARENESS FOUNDATION, INC.

ARTICLE II: ADDRESS
