I, the undersigned incorporator, here make, acknowledge and file these Articles of Incorporation for the purpose of becoming a corporation not for profit under the laws of the State of Florida.

#### I. NAME

The name of the Corporation shall be Ladies of the Light, Inc., a not for profit corporation.

# II. PURPOSE

Said corporation is organized exclusively for charitable, educational, religious or scientific purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code.

# III. INITIAL REGISTERED AGENT AND STREET ADDRESS

#### VIII. CORPORATE POWERS

The powers of this corporation are as provided in Section 617.0302 of the Florida Statutes and are not limited hereby.

# IX. NO PRIVATE INUREMENT AND POLITICAL PARTICIPATION

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the

carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

# X. RACIAL NON-DISCRIMINATION

The corporation shall have a racially non-discriminatory policy and therefore shall not discriminate against applicants, students, employees and others on the basis of race, color or national or ethnic origin.

#### XI. EXEMPT ACTIVITIES

Notwithstanding any other provisions of these Articles, the corporation shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or by an organization, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

# XII. DISSOLUTION OF CORPORATION

Upon dissolution of this corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, i.e. charitable, educational, religious or scientific, or corresponding section of any future federal tax code, or shall be distributed to the Federal government, or to a state or local government for a public purpose.
