ARTICLES OF INCORPORATION
OF

The undersigned incorporator(s), a natural person 18 years of age or older, in order to form a corporate entity under Florida Statutes, Chapter 617, F.S. (Not for Profit), adopts the following articles of incorporation.

ARTICLE I
NAME

The name of the corporation shall be known as:
World Reach 2000 Ministries, Inc.

ARTICLE II
PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:
World Reach 2000 Ministries, Inc.
476 Sherwood Rd.
DeFuniak Springs, Florida 32435

ARTICLE III
PURPOSE

The purpose for which the corporation is organized is: exclusively for charitable, educational, and spiritual evangelism of those people groups located in what is known as the 10/40 window of the world. Specifically to be a Christian Outreach Ministry for the People Groups of India. To this end, the corporation shall at all times be operated exclusively for charitable purpose within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

ARTICLE IV
MEMBERSHIP

The Board of Directors has set forth the following criteria for membership:

Section 1: Initial Membership Fee of \$75.00. New members will receive membership certificate and packet and be entitled to one (1) year membership.

Section 2: Annual dues of \$35.00 payable within 30 days of one year anniversary.

Section 3: Membership may be established for terms of one (1) year; five (5) years; ten (10) years; or Lifetime.

Section 4: One (1) year: Membership Fee of \$75.00

Five (5) year: Membership Fee of \$300.00

Ten (10) year: Membership Fee of \$500.00

Lifetime: Membership Fee of \$1000.00

Section 5: Member Benefits: One year and five year and ten year members will receive a regular newsletter update of the work for Christ in India and the operations of World Reach 2000 Ministries, Inc.

Lifetime Members will be afforded the opportunity to travel with World Reach 2000 Ministries to Kota, Rajasthan, N. India, for an annual 10 day missionary pilgrimage and see the work for Christ in India and be a part of the World Reach 2000 Ministries Team.

ARTICLE V
MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The management of affairs of the corporation shall be vested in a Board of Directors which shall serve a perpetual term as outlined in the corporation's bylaws and charter. The initial Board of Directors are appointed by the Founder/CEO, whose name appears in the Article. Subsequent officers and directors will be chosen by majority vote; with the vote of the Founder/CEO being the decisive vote. 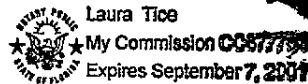
