We, the undersigned, being desirous of forming a corporation on charitable, philanthrophic and religious purposes under the provisions of Chapter 817 of the Florida Statutes, do agree to the following:

### ARTICLE I

The name of this corporation is THE CHURCH OF ELI AND JESUS THE CHRIST, INC.

#### ARTICLE II


