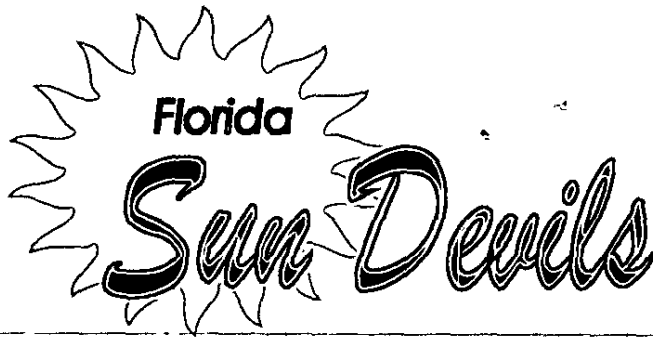

To Whom It May Concern,

On March 22, 2003 our Incorporated Non-Profit Youth Baseball League received a letter that indicated that Florida's Division of Corporations had administratively dissolved our Corporation for failing to submit its annual report for the 2002 year.

We dispute this, as not in fact since I personally completed the report and we are in receipt of the cancelled check cashed by your office. This particular U.B.R. was returned to me in April 2002 since I failed to use proper Letter codes in section #10 in identifying Officer and Directors. I completed the corrections and the form was mailed back to the Division of Corporations.

On March 24, 2003 I spoke to Document Specialist, Eula Peterson, who explained that the Division did receive the initial report but had not received the corrected report. She also indicated that the division had received the payments for 2002 transaction and the 2003 report, which was returned to me. These checks were posted on April 9, 2002 90735 03 \$61.25; February 27, 2003 01017 001 \$61.25.

On behalf of the Florida Sun Devils, Inc. I would request that the Corporation status be reinstated and the \$175.00 reinstatement fee be waived.

Your prompt consideration in this matter would be greatly appreciated.
