## ARTICLES OF INCORPORATION

### ARTICLE I NAME

The name of the corporation shall be *STRINGS N' STRUTTERS, INC.*, a Florida Non-Profit Corporation.

The principal address of the Corporation is *1507 June Avenue / Brooksville, Florida 34601*.

### ARTICLE II DURATION

The duration of the Corporation shall be perpetual. Corporate existence shall commence at the date of these Articles of Incorporation are filed by the Department of State.

### ARTICLE III PURPOSE

The purpose for which the corporation is organized are to dedicate itself by social, educational and charitable means to the appreciation of Music and the Theater.

No assets or revenue or funds they inure to the benefit of any members, directors or officers of this Corporation.
