Articles of Incorporation - Amendment

**Article 3. Purposes.**

**D. Said corporation is organized exclusively for charitable, religious, educational and scientific purposes, including, for such purposes, the making of distributions to corporation under Section 501 (c) (3) of the Internal Revenue Code ( or the corresponding section of any future Federal Tax Code.)**

**Article 4. Members.  
(second and third paragraph)**

**No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to it's members, trustees, directors, officers, or other private persons, except that the corporations shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501 (C) (3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in ( including the publishing or distribution of statements) any political campaign on behalf of , or in opposition to, any candidate for public office.**

**Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by any corporations exempt from Federal income tax under Section 501 (C) (3) of the Internal Revenue Code ( or corresponding section of any future Federal Tax Code ) or (b) by any corporation, contributions to which are deductible under Section 170 (C) ( 2) of the Internal Revenue Code ( or corresponding section of any future Federal Tax Code.)**

**Article 9. Nonstock Basis.**

**Upon the dissolution of this corporation assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (C) (3) of the Internal Revenue Code, or corresponding section of any future Federal Tax Code, or shall be**

**distributed to the Federal government, or to a state or local government, for a public purpose.**

**The Amendments were adopted by the members and the number of votes for the amendments was sufficient for approval.**
