AMENDMENT TO ARTICLES OF INCORPORATION OF WEST HAVE HOMEOWNER'S ASSOCIATION, INC

THIS AMENDMENT TO ARTICLES OF INCORPORATION OF WEST HAVEN HOMEOWNER'S ASSOCIATION, INC. ("Amendment") is made and entered into this zith day of 2021, by WEST HAVEN HOMEOWNER'S ASSOCIATION, INC., a Florida not-for-profit corporation ("Association").

WHEREAS, the Articles of Incorporation of West Haven Homeowner's Association, Inc. are filed with the Division of Corporations for the State of Florida and attached hereto as Exhibit A ("Articles");

WHEREAS, Article XII of the Articles provides that the Articles may be amended without the assent of the membership to correct any ambiguities, scriveners errors or conflicts;

WHEREAS, the Fifteenth Amendment to Declaration of Covenants, Conditions and Restrictions for West Haven creates a new Class "E" Member with regard to the Neighborhood within the Subdivision referred to as "The Glen;" and

WHEREAS, the Association desires to amend the Articles to clarify the voting rights for the Class "E" Member; and

NOW, THEREFORE, the Articles are amended as follows:

- 1. Recitals. The foregoing recitals are true and correct and are incorporated herein by reference and specifically relied upon.
- 2. <u>Amendment</u>. The Association having authority to make such amendments, modifies the Articles as follows (additions are indicated by <u>underlining</u>; deletions are indicated by strikeouts)
- a. Article VI of the Articles shall be deleted in its entirety and replaced with the following:
 - A Member's right to vote in Association matters shall vest as set forth in the Declaration, as amended from time to time. All voting rights of a Member shall be exercised in accordance with and subject to the terms, conditions, restrictions, and limitations provided in the Governing Documents, as defined in Section 720,301, Florida Statutes.
- 3. Effect of this Amendment. Except as modified by this Amendment, all other terms and provision of the Articles shall remain applicable unchanged, and in full force and effect.
