**ARTICLES OF INCORPORATION
OF
DEERLAKE MIDDLE SCHOOL
PARENT TEACHER ORGANIZATION, INC.

(A CORPORATION NOT FOR PROFIT)**

In order to form a corporation under and in accordance with the provisions of Chapter 617, Florida Statutes, for the formation of corporations not for profit, the undersigned does hereby make, adopt and subscribe these Articles of Incorporation, to wit:

I.
NAME OF CORPORATION

The name of the Corporation is Deerlake Middle School Parent Teacher Organization, Inc. (hereinafter referred to as the "Corporation").

II.
ADDRESS OF PRINCIPAL OFFICE

The address of the principal office and the mailing address of the Corporation is 9902 Deerlake, West, Tallahassee, Florida.

III.
PURPOSES

The Corporation is created from and shall be operated exclusively for educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. No part of the net earnings shall inure to the benefit of any private member of the Corporation or of any individual. No substantial part of the activities of the Corporation shall be for the carrying on of propaganda, or for otherwise attempting to influence legislation (except as may be permitted by the Internal Revenue code without jeopardizing qualification of the Corporation as a Section 501(c)(3) corporation). The Corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of (or in opposition to) any candidate for public office.

Any income received by the Corporation shall be applied only to the nonprofit purposes and objectives of the Corporation set forth herein and no part thereof during membership or upon termination of membership shall inure to the benefit of any private member or individual.

IV.
BOARD OF DIRECTORS

The affairs of the Corporation shall be managed by a Board of Directors consisting of at least three (3) directors, the number and election of which shall be as set forth in the Bylaws of the Corporation.

V.
TERM OF EXISTENCE

The term for which the Corporation shall exist shall be perpetual unless dissolved according to law.

VI.
MEMBERSHIP

The Corporation shall consist of general membership. The criteria for membership shall be as set forth in the Bylaws of the Corporation.

VII.
BYLAWS

The initial Board of Directors of the Corporation shall adopt bylaws consistent with these Articles of Incorporation. Thereafter, the Bylaws may be altered or rescinded in the manner provided by such Bylaws.

VIII.
REGISTERED OFFICE

The registered office of the Corporation shall be located at 101 East College Avenue, Tallahassee, Florida 32301, and the registered agent shall be Robert R. McDonald, Esq.

IX.
INCORPORATORS

The Corporation reserves the right to alter, amend, or repeal any provisions contained in these Articles of Incorporation, or any amendment thereto, according to law.

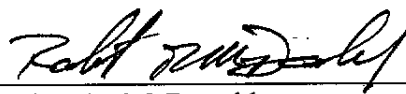
