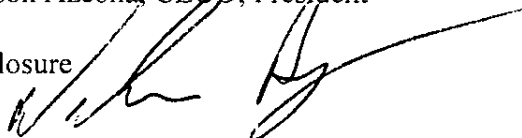

ARTICLE I. CORPORATE NAME

ARTICLE VIII. LIMITATION OF CORPORATE POWERS

Notwithstanding any other provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue law.

ARTICLE IX. DISSOLUTION OF CORPORATION

Upon the dissolution of organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, State or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

The foregoing Restated Articles of Incorporation restate and integrate the provisions of the Corporation's Articles of Incorporation and also contain certain amendments, specifically designated as "AMENDED," to which were adopted pursuant to Section 617.1002, Florida Statutes. There is no discrepancy between the Corporation's Articles of Incorporation and the provisions of the Restated and Amended Articles of Incorporation other than the inclusion of amendments designated above, and the omission of matters of historical interest.
