## ARTICLES OF INCORPORATION MOTIVATIONAL OUTREACH FOR YOUTH & ADULTS, INC

ODDEC 15 PM 1:46 The undersigned, a natural person 18 years of age or older, acting as registered agent, does hereby desire to form a non-profit corporation pursuant to the Federal Guidelines for a non-profit organization under 501 (C) (3) and does hereby adopt the following Articles of Incorporation:

#### Article I – Name of Corporation

The name of the corporation shall be Motivational Outreach for Youth and Adults, Incorporated—acronym, \*

#### Article II – Principal Office; Mailing Address

The mailing address of the principal office of the corporation is P.O. Box 11526 Daytona Beach, FL 32120

#### Article III - General Purpose

This corporation is a private organization established for instructional, therapeutic, and charitable purposes, more specifically to provide choreographed dance training and performance opportunities for socio-economically deprived youth and adults. It also serves to provide outreach that will enrich the community both culturally and educationally, and to therapeutically motivate the physical and emotional disabled individual. This corporation also seeks to provide programs, projects and activities that encourage volunteerism and promote community service among disadvantaged youth and adults within their respective communities.

#### Article IV – Election/Appointment of Directors

The corporation shall have no members. The management of the affairs of the corporation shall be vested in the Board of Directors as defined in the corporation's bylaws. The initial Directors are appointed to serve one year by the Registered Agent of the corporation. All subsequent directors may be either appointed at the discretion of the Registered Agent or elected by the Officers of the Board of Directors. A Board Member may be removed by a two-thirds majority vote of the remaining Board Members.

#### Article V – Exemption Requirements

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof.
