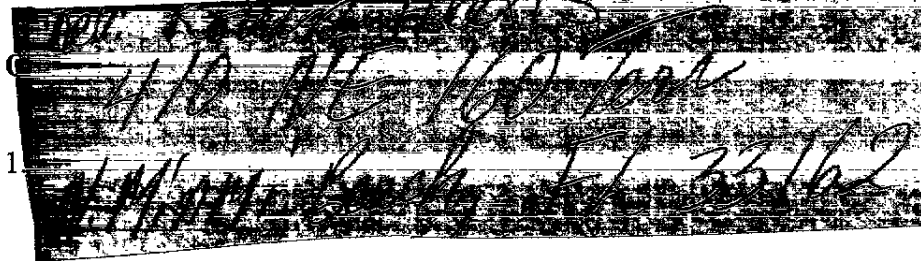

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopt (s) the following Articles of Incorporation for such corporation:

Article I

The name of the Corporation is: **EGLISE BAPTISTE SAMARIE , Inc** and the initial principal address of the Corporation is : 40 & 42, NE 167 St. North Miami Beach, FL 33162.

Article II

The period of the duration of this corporation is perpetual unless dissolved according to law. Corporate existence shall commence upon filing

Article III

The purpose or purposes for which the corporation is organized are: Notwithstanding any other provisions of these Articles the purposes for which the organization is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Article IV

Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on by organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Article V

The qualifications for member and the manner of their admission :
This organization is open to the general public at large; that is any person who of his/her own volition desire to be a member.

Article VI

Article VIII


The Corporation is organized under a non stock basis.
