The undersigned natural persons, each of whom is licensed or otherwise legally authorized to do business in the State of Florida, hereby form a corporation in accordance with the laws of the State of Florida and hereby adopt the following Not for Profit Articles of Incorporation for such corporation.

ARTICLE I. NAME.

The name of the corporation shall be: **UNIDOS A JESUS CORPORATION**

ARTICLE II. PRINCIPAL OFFICE.
