ARTICLES OF INCORPORATION
OF
NEW HARVEST MINISTRIES, INC.

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, do hereby certify as follows:

Article I Name:

NEW
The name of the corporation shall be *NEW* Harvest Ministries, Inc.

Article II Principal Office:

The principal place of business and mailing address of this corporation shall be:
342 So. Katherine Ave., Panama City, Florida 32404.

Article III Purposes:

Said corporation is organized exclusively for religious purposes including for such purposes:

- A. To establish and maintain churches based on the Gospel of Jesus Christ.
- B. To provide places of worship and prayer.
- C. To teach, preach and study the Gospel of Jesus Christ.
- D. To Advance membership in *NEW* Harvest Ministries, Inc.
- E. To proclaim the Christian Faith and to disseminate information regarding the same and to proclaim the truth of the Holy Bible.
- F. To improve the spiritual, mental, physical and social conditions of men, women and children through the Word of God and so to promote the advancement and glory of Christ's Kingdom by missionary, benevolent and church school work.
- G. To conduct retreats for the purpose of Christian growth.
- H. To establish, maintain and conduct a school for religious instruction.
- I. To bring the Gospel of Jesus Christ and the ministry of Christian love to those not reached.
- J. To produce and promote resource material, tapes, videos and any & all types of Media for the furtherance of the Gospel of Jesus Christ.

Article IV Manner of Election:

The manner in which the directors are elected or appointed:

Section I: A meeting of persons interested in the formation of Harvest Ministries Inc. was called and held in conformity with the Law at 19909 Claude Circle, Panama City Beach, Florida on the 20th day of October, 2000 at which the following persons were represented:

Section II Current Officers:

The names of the persons appointed as officers and the terms of office for which they are respectively appointed are as follows:

Todd J. Beal-President to hold office for an indefinite term; Sonjah D. Beal-Vice-president, Secretary/Treasurer to hold office until the second annual election thereafter; and David C. Beal/Trustee to hold office until the first annual election thereafter.

Article VI Place of Operation:

The Corporation shall conduct and carry on its activities in any state or territory of the United States or in any foreign country in conformity with the laws of such state, territory or foreign country.

Article VII:

Section I First Annual Election:

The first annual election of trustees shall be held on September 15th 2001, and the annual election of trustees shall each year thereafter be held on the 15th day of September and if the same falls on a legal holiday or a Sunday, it shall be held on the first business day thereafter.

Section II Income and Distribution:

No part of the net earnings of the Corporation shall inure to the benefit of any member or officer of the Corporation or to any private individual (except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof. No member or officer of the Corporation or any private individual shall be entitled to share in the distribution of any of the Corporate assets upon dissolution of the Corporation.

Section III Distribution on Dissolution:

In the event of dissolution of the corporation all of the remaining assets and property of the Corporation shall, after necessary expenses thereof, be distributed to such organizations as shall qualify under Section 501 (c) (3) of the Internal Revenue Code or the corresponding section of any future federal tax code as the Board of Trustees shall determine or to another organization to be used in such manner as in the judgment of a Justice of the Supreme Court of the State of Florida that will best accomplish the general purposes for which this corporation was formed.

Section IV Prohibited Activities:

No substantial part of the activities of the Corporation shall be carrying on propaganda, or otherwise attempting to influence legislation or participating in or intervening in (including the publication or distribution of statements) in any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

Section V Age of Subscribers:

The subscribers hereof are of the age of 21 years and more.

Section VI Effective Date:

The effective date of incorporation shall be December 18, 2000.


